

## **PERSONAL DATA:**

In view of the fact that Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter GDPR, is the regulation in force applicable to personal data, you are hereby advised as follows:

- 1) Zamek Culture Centre, with registered office at ul. Św. Marcin 80/82, 61-809 Poznań, is the Controller of your personal data.
- 2) As your data will be processed by Zamek Culture Centre, you may contact the Personal Data Protection Officer appointed by the Controller by e-mail at [iod@ckzamek.pl](mailto:iod@ckzamek.pl) or in writing to the address of the Controller.
- 3) Personal data will be processed:
  - a) for the purpose of participating in the submissions for the Competition for Features in the St Martin Street Name Day Parade 2024, under consent given in line with Article 6(1)(a) GDPR,
  - b) for the purpose of performing the agreement and taking part in the Competition for Features in the St Martin Street Name Day Parade 2024, under an agreement concluded in line with Article 6(1)(b) GDPR,
  - c) for the purposes of recording, photographing, filming or otherwise registering the image and statements (or their fragments) of the Participants in the Competition for Features in the St Martin Street Name Day Parade 2024 for subsequent publication in online and written media, in information and publicity materials as well as on the websites of the Organizer and entities collaborating with the Organizer, i.e. the Poznań City Hall, under consent given in line with Article 6(1)(a) GDPR,
  - d) in order to comply with legal obligations resting with the Controller, including additional and accounting obligations, pursuant to Art. 6(1)(c) GDPR.
- 4) Your data will be processed by authorized employees and associates of the Controller. Such data will be received by entities which provide services to the Controller, in particular services relating to access to IT systems, IT support and maintenance, as well as hosting services.
- 5) In most cases, your personal data will not be transferred outside the European Economic Area or shared international organizations. Personal data may be

transferred to third countries in connection with the use of Google's affiliated services; however, in such cases, the transfer of data is governed by contractual agreements, provisions that guarantee an adequate level of personal data security.

- 6) Your data will be processed for the duration of the agreement and the period specified in applicable laws and regulations, including statutes of limitation on potential claims.
- 7) You have the right to:
  - a) access to the content of your personal data,
  - b) rectify processed data, have the data erased, restrict the processing of data,
  - c) object to processing,
  - d) withdraw consent, without prejudice to the lawfulness of actions taken prior to its withdrawal.
- 8) Should you find that data processing violates applicable personal data protection laws and regulations, you are entitled to file a complaint with the regulatory authority, i.e. the President of the Office for Personal Data Protection, at the address of the Personal Data Protection Office, ul. Stawki 2, 00 - 193 Warsaw.
- 9) Personal data is supplied voluntarily, but it is indispensable in order to submit an entry for the Competition for Features in the St Martin Street Name Day Parade 2024. Participation in the submissions or performance of the agreement is not possible if said data is not provided. Although the consent to image use is voluntary, it is indispensable in order to participate in the Competition.
- 10) Your data will not be used for automated decision-making or profiling.
